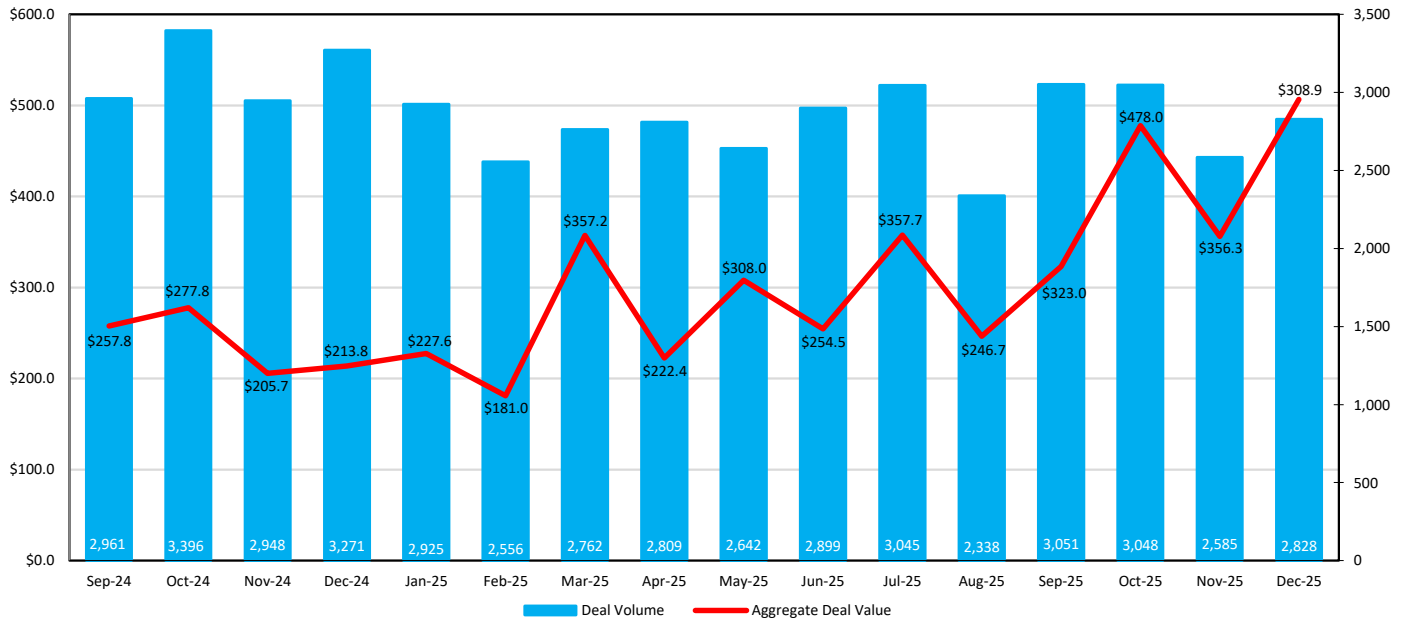

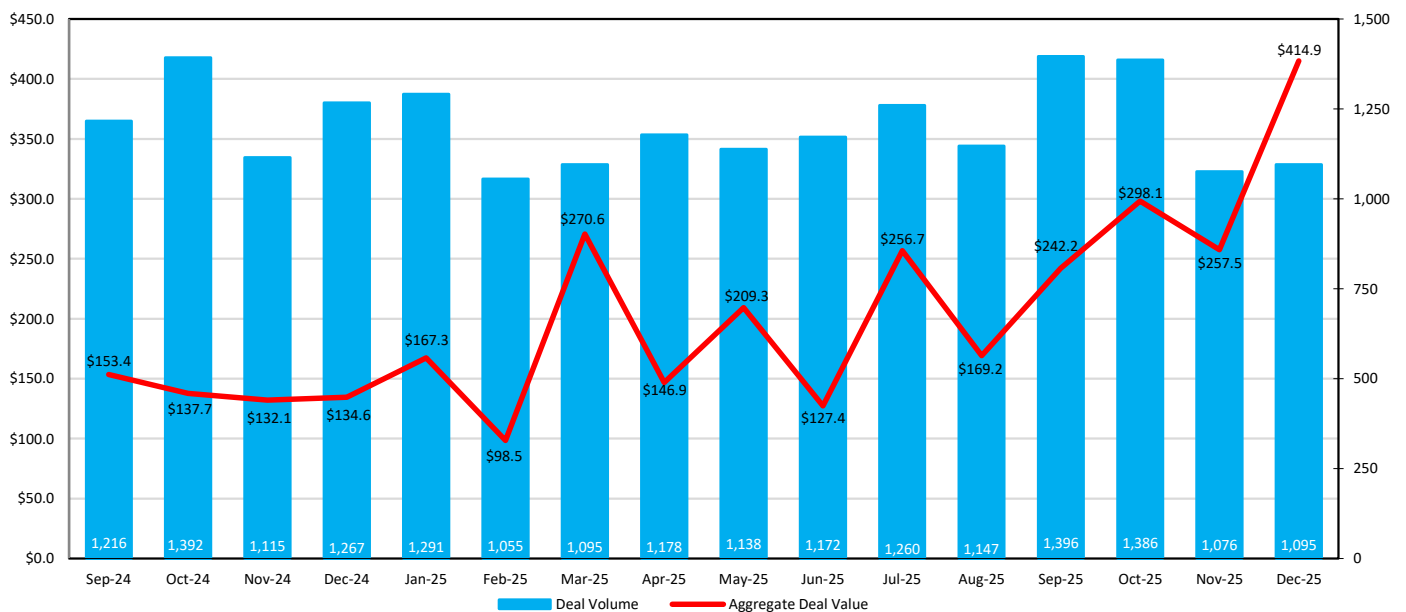

The Global Mergers & Acquisitions Market Index



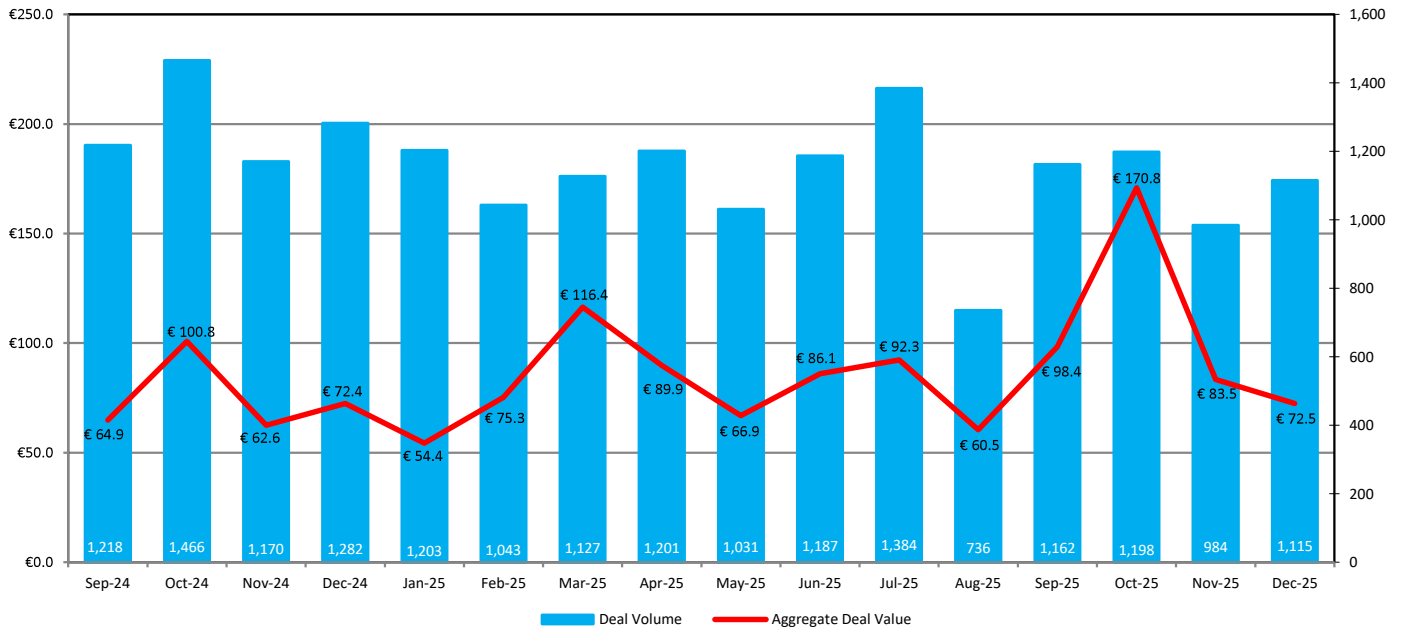
The US Mergers & Acquisitions Market Index



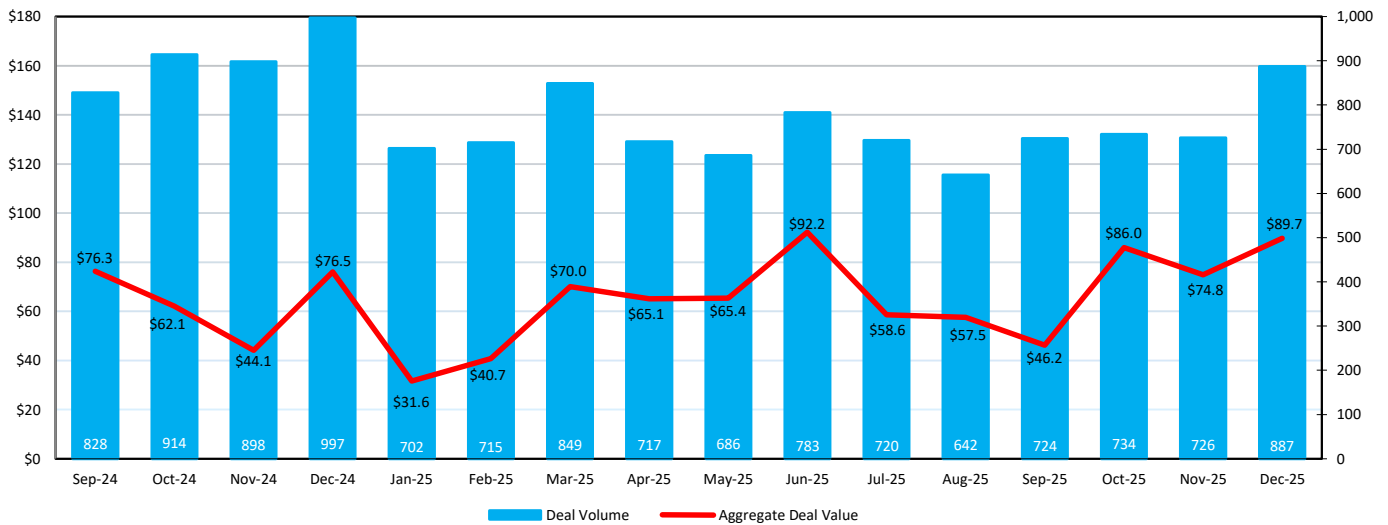

The Europe Mergers & Acquisitions Market Index



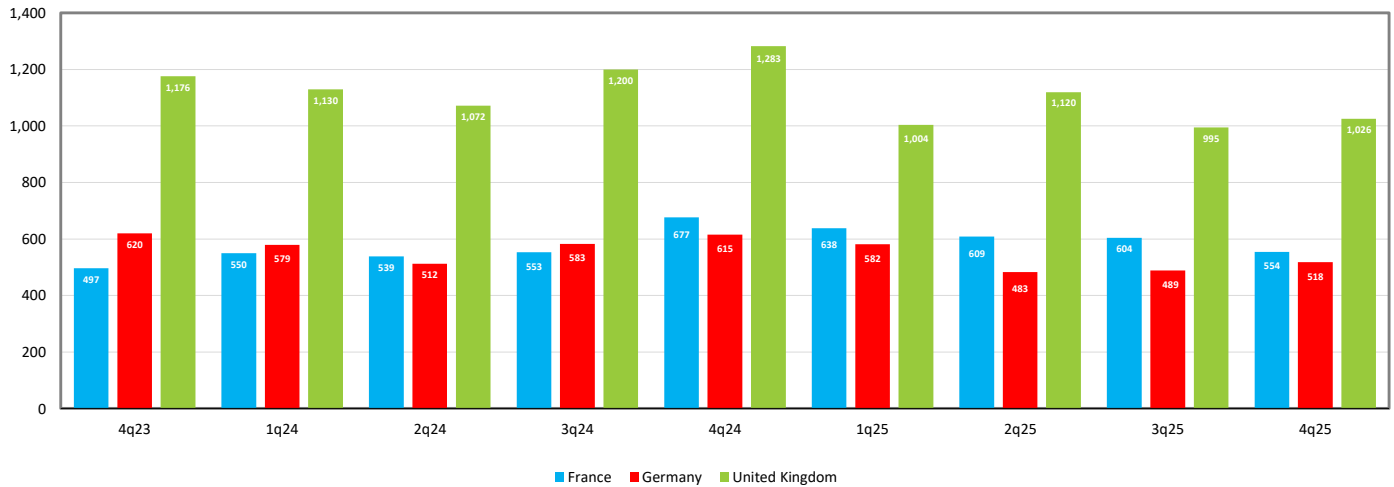

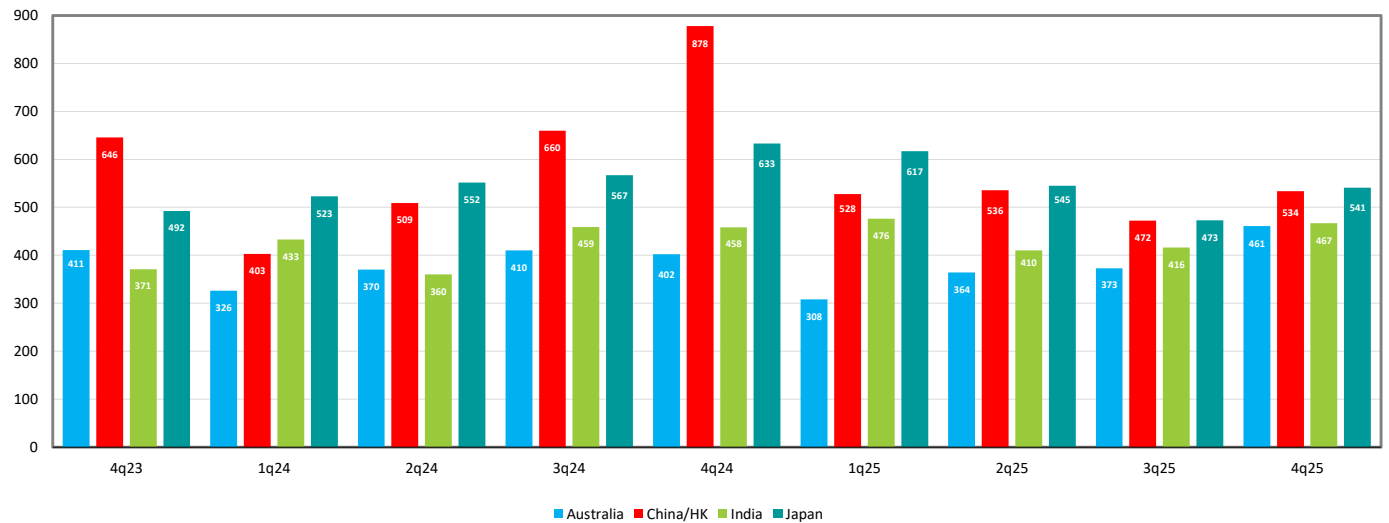
