- Steve Wolosky handled a successful proxy contest at the 2009 annual meeting of a Japanese company in which shareholders elected all of our client's candidates in a rare victory for shareholder activism in Japan.
- Thomas J. Fleming and Steve Wolosky represented a hedge fund in Delaware where dissident investors were denied an injunction against our client to halt plans to restructure into a publicly traded company.
