- 631 new activist campaigns were launched in 2022, versus 588 campaigns in 2021, a 7.3% increase. The 177 campaigns announced in Q4 were the most in a quarter since Q2 2018.
- Campaigns at \$1b+ companies were up 4.5% from 223 to 233 while sub-\$1b campaigns were up 9%.
- The U.S. saw a resurgence in activism. Campaigns in the United States were up 24% from 288 in 2021 to 356 in 2022, and \$1b+ campaigns were up 38% from 102 to 141.
- Activity in Europe fell 25%, from 110 new campaigns in 2021 to 82 in 2022. \$1b+ campaigns in Europe fell 42%, from 71 to 41.
- Activists took advantage of the decline in tech valuations to launch 94 new technology campaigns, up 74% from 2021. High-profile targets included Salesforce, PayPal, and Fidelity National Information Services.



Activism Screening Model

- The Bloomberg Activism Screening Model aims to identify which companies are most likely to face activist campaigns in the next 12 months.
- In 2022, of the 29 companies in the top 1% of the Russell 3000 (excludes companies already subject to campaigns), 5 (17.2%) were targeted by activists, while 4.7% of all companies in the Russell 3000 were targeted, for a hit rate in the top 1% that was 3.7x higher than the Russell 3000 average. The 5 companies were Bed Bath & Beyond (#8), Neuronetics (#12), Sientra (#18/tie), Big Lots (#18/tie) and Tabula Rasa HealthCare (#22).
- In the top 5% of the Russell 3000 ranking, 9.9% of companies were targeted (see chart below).
- Of the 28 companies in the top 5% of the Stoxx Europe 600 (excludes companies already subject to campaigns), 7 companies were targeted by activists (25.0%), compared to 3.5% of all Stoxx 600 companies, for a hit rate 7.2x higher than the Stoxx 600 average. The 7 companies were Fresenius (#2), Bayer (#3), Atos (#4), Philips (#12), Deutsche Lufthansa (#14/tie), ProSiebenSat.1 (#14/tie) and SKF (#25).
- Five of the 224 ranked companies in the S&P TSX Composite were targeted in 2022. Three were in the top 25: IAMGOLD (#8), Kinross Gold (#19), Suncor (#24).

Methodology

Bloomberg League Criteria

Eligible Advisers:

- All financial advisers, legal advisers, investor relations/public relations advisers and proxy solicitors that advise the company or activist on activism or major M&A-related matters during the course of an activist campaign.
- Advisers to a target company (or to board/special committee) receive company-side credit.
- Advisers to a member of the activist receive activist-side credit.
- Advisers to third parties do not receive credit, such as legal advisers to financial advisers and advisers to acquirers in deals where a target shareholder opposes the merger.

League Table Credit:

- An engagement will be given league table credit for a given year as long as the campaign was active within that year. Activity is defined as one or more of the following events occurring in that year:
 - Campaign began.
 - New activist objectives disclosed.
 - Contested meeting started, ended or pending.
 - Other major event occurs (i.e. settlement, lawsuit, activist letter).
 - Activist public statement during hostilities.
- Only one engagement per target company per year will be counted for league table ranking purposes.
- For closed-end funds, only one engagement per ultimate parent will be counted.
- Engagements privately submitted to Bloomberg are eligible for league table credit and are available for review on BI ACTLEAG <GO>.

General Database Criteria

Included Campaigns:

- Shareholder is publicly seeking to make changes at a company without company cooperation.
- Known activist gets board seat or takes large stake at a company without disclosing public activist intentions.
- Credible news reports of above situations.
- Hedge fund or known activist files 13D after purchasing shares on the open market.
- Unsolicited bids by financial acquirers with toehold stakes.
- Japanese Significant Shareholder Filings/Mass Holding Reports where "Holding Purpose" field discloses activist intentions.

Not Included:

- Proposals by small/ESG shareholders.
- Stakes disclosed in 13F or 13G filing without accompanying activist intentions.
- Campaigns where investor owns debt, not equity.
- Short-selling campaigns.
